### **Certification is Required to Perform Hot Work in Massachusetts**

Hot Work involves any activity that uses flames or produces sparks and/or excessive heat. Anyone conducting Hot Work in Massachusetts should attend the training and get certified. **Effective July 1, 2018** the State will require certification as a condition to perform Hot Work in all Massachusetts towns.

Created by NFPA, the Hot Work Safety Certification Program consists of a two-hour seminar and one-hour test. The program defines Hot Work and the measures required to safely perform work.

**Participants must pre-register. No on-site registration.**
